Dear Dr. Madhavi

In reference to your letter dated---- concerning the appointment of our International Parliament - IPNWG Director to Paraguay Mr. Rabih Ghattas kindly not our disappointment on that. We were not accepting such reaction from your side especially and after your last conversation with us on Facebook and left us in an non trust position. Although we have informed you previously on Mr. Ghattas nomination and documents were sent to your good office, therefore and since we feel that the interpretation of our appointment as Secretary General within IHRO varies a lot from the main International principles and Laws; Therefore a forward action to emphasis our authorities by an official letter stamped by Justice authorities in India to appoint and write to Foreign States and refer all information to the headquarter for action is needed. In case this could not meet your approval, we suggest the following points to continue our mutual cooperation:

- 1- The International Human Rights Observatory (IHRO) shall enter into an MOU with the International Human Rights Middle East (IHRM) considering the following notes within the agreement:
- a) All appointees at IHRM shall be acceptable and nominated automatically with IHRO after submitting a detailed letter from the IHRM Secretary General on the applicants with full needed information.
- b) IHRO shall issue a joint Certificate and Notification letter to the IHRM applicants and be signed by the IHRO official Trustees and it's Secretary General.
- c) IHRO shall have the rights to retrieve an entrance fees from applicants to cover applicant ID and notification letter.
- d) IHRM and after signing the MOU with IHRO shall register it with needed authorities local and worldwide.
- 2- All information and follow up with the duplicate applicants (IHRO-IHRM) shall be through the mutual Secretary General Ambassador Dr. HAISSAM BOU-SAID.

- 3- IHRO Secretary General Amb. Dr. HAISSAM BOU-SAID shall make all the necessary letters with various States to assure IHRO Status as IGO.
- 4- All letters of mutual applicants (IHRO-IHRM) to the applicants Governments shall be written by the Secretary General where a copy of such should be sent immediately after to the IHRO Headquarter.

Failure to endorse the requirements herein shall leave us in a position of open resignation from the IHR OBSERVATORY definitely and with all respect to the Board of Trustees.
